Message from Director General



The emerging technologies globally have noticed substantial adoption in 2017, and that's a beacon to the tremendous growth in economic spheres in future. STPI is also working to create an ecosystem so that industry, startups and MSMEs of IT sector can also leverage these disruptive technologies for their growth and also for the benefits of the mankind at large.

The year 2017 witnessed a remarkable journey in terms of disruptive technologies – some technologies registered momentous adoption and some technologies left indelible marks for groundbreaking innovations that would muster growth in the coming times. Nevertheless, disruptive technologies dominated 2017 in a far more meaningful way than ever before.

According to a research report published by KPMG, the venture capital investment in artificial intelligence and machine learning has grown to USD 12 billion in 2017 from USD 6 billion in 2016 globally. The sharp rise of funding in artificial intelligence indicates that this emerging technology has certainly a bright future globally. In 2017, Indian AI startups fared rather well. According to a research report, Indian AI startups raised USD 87.85 million across 58 deals.

In 2017, blockchain technology got a massive traction in sectors like financial services, real estate, supply chain, governance and energy distribution. Globally, blockchain startups attracted around USD 2 billion VC funding in 2017. Indian startups focused on blockchain were not far behind their global peers. Many state governments in India exhibited their interest to create use cases for adopting blockchain in e-governance.

Employment Generation At Regional Level



A comprehensive review on the performance of India BPO Promotion Scheme (IBPS) for Tamil Nadu and Puducherry was conducted by Shri Ravi Shankar Prasad, Hon'ble Union Minister of Law & Justice and Electronics & Information Technology on 23rd December 2017 at Chennai.

During the review meeting, Dr. Sanjay Tyagi, Director, STPI-Chennai explained the progress of implementation of IBPO Scheme in Tamil Nadu and Puducherry in detail.

Hon'ble Minister had an exclusive interaction with the IBPS units located in Tamil Nadu and Puducherry and he emphasized on the employment generation in Tier II & III cities. While reviewing performance of BPO units, the Minister appreciated the efforts of industries and entrepreneurs for starting operations under IBPS in the state.

Further, the Minister invited big companies like Amazon and Newgen to start operations in other states like Bihar, UP, MP and Rajasthan.

In the state of Tamil Nadu and Puducherry, 4200 seats have been allotted under IBPS at the end of 5th round of RFP. After the 5th round, 23 eligible companies have been allocated seats to set up BPO/ITES operations. The major area of activities carried out by the BPO units are banking, NBFC, e-Learning, Typesetting, e-commerce, e-publishing, Helpdesk for PDS etc.
