Incubation facilities in STPI (Guwahati Directorate)

Type of Incubation facility:

- Plug-&-Play incubation seat
- Raw Incubation space.

Facilities provided:

- Plug-&-Play incubation seat include Bandwidth, Electricity (including DG backup), Desktop with furniture (seat wise), UPS backup, Air Conditioning facility etc. It is a ready to use facility and incubatee can start their work immediately.
- State of the art raw incubation space to the unit.

Tariff of Incubation facility:

- Tariff for Plug-&-Play incubation seat is Rs. 3000.00/seat/month.
- Tariff for raw incubation space is Rs. 10.00 / sq. ft. per month. Electricity and other facilities are charged as per actual consumption.

Procedure for allotment of Incubation Facilities in STPI

- Intending incubatee has to apply to the In-Charge of STPI center along with their documents (**APPLICATION FOR INCUBATION FACILITY** enclosed herewith).
- Received proposal is checked for completeness by the respective STPI center.
- The examined proposal is placed before the advisory board.
- The advisory board examines the proposal based on various parameters having weightage as below.
- The incubation allotment is done on the basis of first come first serve, once it is approved.
