

Instructions to the nominated Nodal Officers of STPI Member Companies:

The nominated Nodal Officers from the STPI Member Companies for coordination for Digital India Week (DIW) with STPI, may note the following for successful execution of the DIW in their offices:

1. The Nodal Officers may make arrangements for the broadcast of the inaugural program to be graced by Honorable Prime Minister on 1st July' 2015 starting at 16:00 hours at IG Stadium, New Delhi, for all the employees.
2. The Nodal officers may organize the DIW event at their respective companies preferably on the 2nd July 2015 and share the schedule with STPI for information.
3. The Nodal officers may prepare the list of participants, speakers and their topics w.r.t the talk planned to be delivered in their office during DIW.
4. The Nodal officers may make arrangements for photography/videography of the events being held at their locations and share the same with STPI.
5. The Nodal Officers may publish the activities being held prior to the event, during the event and post event on the Company Web Pages regularly. The same may also be shared on social media platforms. Links for Twitter/ Facebook of STPI is being shared for including the same in in your messages/tweets.
6. The Nodal Officers may make arrangements for showcasing the inaugural event in their common area with the available platform at their location.
7. The Nodal Officers may share the report on the event organized as indicated in the program agenda after the conclusion of the event, with STPI.

- Digital India Exhibition-stalls / MyGov registration (Optional)
- Screening of Digital India Film and Video, Launch of new e-Services of the mission if any planned
- Distribution of DI collaterals (cap, pen etc)
- Display of modules on Digital Literacy and Cyber Security & Hygiene

- Announcement of Local competitions that will be organized by the organization companies from July 2-7, 2015 with awards to winners
- Ensuring remote participation in the 1st July PM's event through registration on the online portal <http://www.diweek.cloudapp.net>
 - Registration of Employees / Participants
 - Stakeholders
 - CEOs of Companies
- Participation of CEOs/Heads of companies accompanied with some of their employees in the Main Event at IG Stadium.
- Instruct all employees to watch the main event at their premises through TV/webcasting
