- a) The Disposal of obsolete items at STPI-Tirupati as given in **"List-A"** shall be sold out on "**As is where is basis**" to the highest offered bidder (H1) through electronic tender cum auction.
- b) **Tender-cum-Auction Process:** The selection will be done in two stages i.e., Technical Bid and e-Auction relating to GeM portal.
- c) **e Auction**: Auction will be done through the GeM portal as per scheduled date and time. The start price of the auction will be the price offered by H1 bidder in financial bid. After completion of auction, final H1 bidder will be declared.
- d) Bidders should sign on all the pages of the tender document.
- e) Bidders are requested to inspect items at the office STPI-Tirupati (As per the location at page-2) from 07/07/2023 to 23/07/2023 (from 10:00 AM to 4:00 PM) on working days only.
- f) The bidders should inspect the materials before submitting tender. It is presumed that they are deemed to have inspected the materials once they submit their tender whether they have actually inspected or not and the principle of "CAVEAT EMPTOR" will apply. No complaints will be entertained after the acceptance of the tender. Interested bidders are requested to quote their rate as per the tender inspected by them.
- g) All bidders should submit "bid security declaration" as per Annexure-VI.
- h) The bidders are required to submit the following documents (self-attested) along with bid document in the GeM portal.

- i) STPI shall not be responsible for any damage to the persons during the segregation and the transportation of materials. All the risks and consequences in this regard shall vest solely with the successful bidder only.
- j) Bids submitted without valid copies of registration certificate for e-waste issued by the concerned Authorities shall be rejected summarily and shall not be considered for evaluation.



- k) Items should be disposed-off as per the guidelines and stipulation of Pollution control Board. Bidder will make their own arrangement for statutory permissions and lifting/shipment of items.
- The bidder should ensure that the facility & recycling process are in accordance with the standards laid down in the guidelines published by the State Pollution Control Board (SPCB) /Central Pollution Control Board (CPCB) from time to time.
 Certificate of Destruction to be submitted to this office after recycling as per norms and the certificate should be submitted within 30 days.
- m)Successful bidder has to submit DD / Banker's Cheque of **Rs.10,000** (Rupees Ten Thousand only) payable to STPI-Hyderabad for amount quoted **within 7 days** from the date of award of contract. The amount can also be paid by way of transfer through NEFT/RTGS. The details are as follows:

4. Award Criteria:

- a. Contract will be awarded on the basis of the highest financial bid (H1) in E-Auction through the GeM portal of those bidders who complies with all terms and conditions of the tender. Only those financial bids where the quoted value is over and above the reserved price plus applicable tax only will be considered.
- b. In case of more than one vendor emerging as H1, contract will be awarded as per GeM guide lines OR else highest turnover declared by the bidder.



c. The successful bidder shall deposit refundable interest free amount of **Rs.10,000/-**(Rupees Ten Thousand Only), which will be refunded after submission of '**Certificate of Destruction**'.

5. Rejection of the bid:

- a) The bidder is expected to examine all instructions, formats, terms & conditions, & scope of work in the bid document. Failure to furnish all information required as per bid document or submission of bid which is not substantially responsive to the bid document in every respect may result in rejection of bid. In respect of interpretation / clarification of this bid document and in respect of any matter relating to this bid document, the decision of STPI will be final.

6. Blacklisting

7. Arbitration

Any dispute or difference whatsoever arising between the tenderer and STPI shall be settled by arbitration in accordance with the provisions of the Arbitration and Conciliation Act, 1996. In such case the same shall be referred to the sole arbitration of Director, STPI-Hyderabad. The award of the arbitrator shall be final and binding on both the parties. The venue of the arbitration shall be at Hyderabad. The language of arbitration shall be in English. Legal issues, if any, will strictly be under jurisdiction courts in Hyderabad only.
